

## NOTICE OF ELECTION

NOTICE IS HEREBY GIVEN that the Board of Trustees of Richardson Independent School District has called a bond election to be held within the District on Saturday, May 1, 2021. Below is a substantial copy of the Order adopted by the Board of Trustees of the District calling the bond election. ### AN ORDER BY THE BOARD OF TRUSTEES OF THE RICHARDSON INDEPENDENT SCHOOL DISTRICT CALLING A BOND ELECTION TO BE HELD WITHIN THE DISTRICT; MAKING PROVISIONS FOR THE CONDUCT AND THE GIVING OF NOTICE OF THE ELECTION; AND CONTAINING OTHER PROVISIONS RELATING THERETO

WHEREAS, the Board of Trustees (the "Board") of Richardson Independent School District (the "District") finds that an election should be held to determine whether the Board shall be authorized to issue bonds of the District in the amounts and for the purposes hereinafter set forth; and

WHEREAS, the Board finds and determines that all facilities to be acquired, constructed, renovated, improved or equipped pursuant to Proposition A herein will be used predominantly for required classroom instruction and essential administrative operations for faculty and staff; and

WHEREAS, the Board finds and determines that the meeting at which this Order is considered is open to the public, and that the public notice of the time, place and purpose of the meeting was given, as required by Chapter 551, Texas Government Code, as amended;

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF RICHARDSON INDEPENDENT SCHOOL DISTRICT:

Section 1. Findings. The statements contained in the preamble of this Order are true and correct and are hereby adopted as findings of fact and as a part of the operative provisions hereof.

Section 2. Election Ordered; Date; Propositions. A bond election (the "Election") shall be held in the District on Saturday, May 1, 2021 ("Election Day"), a uniform election date as established by Section 41.001(a) of the Texas Election Code, as amended (the "Code"). At the Election, the following propositions (individually, the "Proposition" and collectively the "Propositions") shall be submitted to the qualified voters of the District in accordance with law:

#### RICHARDSON ISD – PROPOSITION A

Shall the board of trustees of Richardson Independent School District be authorized to issue and sell bonds of the District in the principal amount of \$694,000,000 for the purpose of acquiring, constructing, renovating, improving and equipping school buildings of the District, for the purchase of necessary sites for school buildings, for the purchase of new school buses, for the retrofitting of school buses with emergency, safety, or security equipment, and for the purchase or retrofitting of vehicles to be used for emergency, safety, or security purposes; and shall there be levied, assessed and collected annually ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds as the same become due and to pay the costs of any credit agreements executed or authorized in anticipation of, in relation to or in connection with the bonds; said bonds to be issued in one or more series or issues, to mature serially or otherwise not more than 40 years from their date, and to bear interest at such rate or rates not to exceed the limit prescribed by law at the time of issuance, as the board of trustees in its discretion shall determine?

#### RICHARDSON ISD – PROPOSITION B

Shall the board of trustees of Richardson Independent School District be authorized to issue and sell bonds of the District in the principal amount of \$56,000,000 for the purpose of acquiring, improving and equipping technology and technology infrastructure, including computers and tablets and other technology devices for the District; and shall there be levied, assessed and collected annually ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds as the same become due and to pay the costs of any credit agreements executed or authorized in anticipation of, in relation to or in connection with the bonds; said bonds to be issued in one or more series or issues, to mature serially or otherwise not more than 40 years from their date, and to bear interest at such rate or rates not to exceed the limit prescribed by law at the time of issuance, as the board of trustees in its discretion shall determine?

Section 3. Official Ballot. The official ballots for the Election shall be prepared in accordance with the Code so as to permit the electors to vote "FOR" or "AGAINST" each Proposition which shall be set forth on the ballots substantially in the following form:

 AGAINST ) CONSTRUCTING, RENOVATING, IMPROVING AND EQUIPPING SCHOOL BUILDINGS, FOR THE PURCHASE OF NECESSARY SITES FOR SCHOOL BUILDINGS, THE RETROFITTING OF SCHOOL BUSES WITH EMERGENCY, SAFETY, OR SECURITY EQUIPMENT, AND FOR THE PURCHASE OR RETROFITTING OF VEHICLES TO BE USED FOR EMERGENCY, SAFETY, OR SECURITY PURPOSES AND FOR THE PURCHASE OF NEW SCHOOL BUSES; AND THE LEVYING OF A TAX SUFFICIENT, WITHOUT LIMIT AS TO RATE OR AMOUNT, TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS AND TO PAY THE COSTS OF ANY CREDIT AGREEMENTS EXECUTED OR AUTHORIZED IN ANTICIPATION OF, IN RELATION TO OR IN CONNECTION WITH THE BONDS. THIS IS A PROPERTY TAX INCREASE.”

RICHARDSON ISD – PROPOSITION B

- FOR ) “THE ISSUANCE OF \$56,000,000 OF SCHOOL BUILDING BONDS FOR ACQUIRING  
 AGAINST ) AND EQUIPPING TECHNOLOGY INFRASTRUCTURE, INCLUDING COMPUTERS, TABLETS AND OTHER TECHNOLOGY DEVICES; AND THE LEVYING OF A TAX SUFFICIENT, WITHOUT LIMIT AS TO RATE OR AMOUNT, TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS AND TO PAY THE COSTS OF ANY CREDIT AGREEMENTS EXECUTED OR AUTHORIZED IN ANTICIPATION OF, IN RELATION TO OR IN CONNECTION WITH THE BONDS. THIS IS A PROPERTY TAX INCREASE.”

Section 4. Bilingual Election Materials. All notices, instructions, and ballots pertaining to the Election shall be furnished to voters in both English and Spanish and persons capable of acting as translators in both English and Spanish shall be made available to assist Spanish language speaking voters in understanding and participating in the election process.

Section 5. Persons Qualified to Vote. All resident, qualified electors of the District shall be eligible to vote at the Election.

Section 6. Election Precincts, Voting Locations and Voting Hours on Election Day. The polling places for the Election are hereby designated to be those locations identified by the Elections Administrator (as defined herein). Such locations are listed on Exhibit A attached hereto, which is incorporated herein by reference and made a part hereof for all purposes; provided, however, such locations may be changed if so directed by the Elections Administrator without further action of the District. Dallas County or its Elections Administrator is hereby authorized and directed to make such changes in polling locations as may be necessary for the proper conduct of the Election, without further action by the District, and the President of the Board or his/her designee is hereby authorized to update Exhibit A to reflect the locations designated by Dallas County or the Elections Administrator, which locations are hereby approved. Each polling place shall be open from 7:00 A.M. to 7:00 P.M. on Election Day.

Section 7. Early Voting Locations Dates and Times. (a) The Dallas County Elections Department (the “Elections Administrator”) is appointed as the Early Voting Clerk for purposes of this Election (the “Early Voting Clerk”). The early voting places and the addresses for early voting by mail for the Election are hereby designated as set forth in Exhibit B; provided, however, such locations may be changed if so directed by the Elections Administrator without further action of the District. The Elections Administrator is hereby authorized and directed to make such changes in locations as may be necessary for the proper conduct of the Election. The President of the Board or his designee is hereby authorized to update Exhibit B to reflect the locations designated by the Elections Administrator, and such locations are hereby approved. The Elections Administrator and/or Early Voting Clerk are hereby authorized to appoint the members of the Early Voting Ballot board and the presiding judges and alternate judges for each polling location in accordance with the requirements of the Code. Each of the presiding judges shall be authorized to approve the necessary election clerks to assist in conducting the Elections.

(b) Early voting by personal appearance shall be conducted on the days and during the hours set forth in Exhibit B, as may be adjusted by the Elections Administrator without further Board action.

(c) Applications for early voting by mail shall be submitted to the Elections Administrator at the locations identified in Exhibit B.

(d) Voting times may be changed if so directed by the Elections Administrator without further action of the District. The Elections Administrator is hereby authorized and directed to make such changes in voting hours as may be necessary for the proper conduct of the Election.

Section 8. Appointment of Election Officers. The Election shall be conducted under the jurisdiction of the Dallas County Elections Department (the “Election Administrator”) pursuant to a Joint Election Contract (the “Contract”) by and among the District and other participating entities, if any, described in the Contract. The Contract providing for the joint election and the conduct of the Election by the Elections Administrator shall be presented to the Board for consideration and approval. The Superintendent or the Superintendent’s designee is authorized to amend or supplement the Contract to the extent required for the Election to be conducted in an efficient and legal manner as determined by the Elections Administrator.

Section 9. Notice of Election. Notice of the Election shall be given by: (i) publishing a substantial copy of this Order, in English and Spanish, one time not earlier than the thirtieth (30th) day nor later than the tenth (10th) day prior to the date set for the Election, in a newspaper published in the District, (ii) posting a copy of this Order, in English and Spanish on the bulletin board used for posting notices of meetings of the Board and in at least three (3) other public places within the boundaries of the District, not later than the twenty-first (21st) day prior to the date set for the Election and (iii) posting a copy of this Order, in English and Spanish, on the District's website, prominently and together with the notice of the Election and the contents of the Proposition, not later than the twenty-first (21st) day prior to the date set for the Election through Election Day. Additionally, on Election Day and during early voting by personal appearance, this Order shall be posted in a prominent location at each polling place. Notice of the Election shall also be provided to the county clerks and voter registrars of Lubbock County and Hockley County not later than the 60th day before the Election Day; which notice each County is hereby authorized and directed to post to its website not later than the twenty-first (21st) day prior to the date set for the Election.

Section 10. Conduct of Election. The Election shall be held in accordance with the Code, except as modified by the Texas Education Code, the Texas Government Code, and the Federal Voting Rights Act of 1965, as amended, including particularly Chapter 272 of the Code pertaining to bilingual requirements.

Section 11. District's Outstanding Debt. As of the effective date of this Order, the District's aggregate principal amount of outstanding of tax-supported debt was \$568,230,830 and the aggregate amount of outstanding interest on such tax-supported debt was \$261,114,501. The District's total ad valorem tax rate for the current fiscal year was \$1.4047, which is comprised of a maintenance and operations tax rate component of \$1.0547 per \$100 of taxable assessed valuation and a debt service tax rate of \$0.35 per \$100 of assessed valuation. The District's taxable assessed valuation for calendar year 2020, as of the date that the current tax rate was established, was \$26,603,714,558.

Section 12. Issuance of New Debt. The District intends to issue the bonds authorized by the Propositions over a period of years in a manner and in accordance with a schedule to be determined by the Board based upon a number of factors, including, but not limited to, the then current needs of the District, demographic changes, prevailing market conditions, assessed valuations of property in the District and management of the District's short-term and long-term interest rate exposure. Market conditions, demographics and assessed valuations of property vary based upon a number of factors beyond the District's control, and therefore, the District cannot and does not guarantee a particular interest rate or tax rate associated with the bonds authorized by the Proposition. As such, the information contained in this paragraph is provided solely for illustrative purposes and does not establish any limitations or restrictions or create a contract with the voters. The District estimates that, based on the District's current taxable assessed valuation, current market conditions and estimated future growth in the District's taxable assessed valuation, if all of the bonds authorized by the Proposition were issued in accordance with the District's current project finance plan, the maximum interest rate on the bonds is not expected to exceed 3.00%.

Section 13. Voter Information Document. The President of the Board, the Superintendent of the District, or their designee, acting on behalf of the Board, in consultation with the District's General Counsel and bond counsel, is hereby authorized and directed to provide a voter information document, in the form prescribed by Section 1252.052(b), Texas Government Code (the "Information Document").

The President of the Board, the Superintendent of the District, or their designee, acting on behalf of the Board, is further authorized and directed to post the Information Document in the same manner as provided for notice of the Election under Section 9 of this Order, and additionally on the District's website in an easily accessible manner beginning not later than the twenty-first (21st) day before the date set for the Election and ending on the day after Election Day.

Section 14. Necessary Actions. The President of the Board, the Superintendent of the District, or their designee, acting on behalf of the Board, in consultation with the District's General Counsel and bond counsel, is hereby authorized and directed to take any and all actions necessary to comply with the provisions of the Code and the Federal Voting Rights Act in carrying out and conducting the Election, whether or not expressly authorized herein, including making changes or additions to polling places or procedures to the extent required or desirable or as may become necessary due to circumstances arising after the date of this Order.

Section 15. Severability. If any provision, section, subsection, sentence, clause or phrase of this Order, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void, invalid, or unenforceable, neither the remaining portions of this Order nor their application to other persons or sets of circumstances shall be affected thereby, it being the intent of the Board in adopting this Order that no portion hereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality, voidness, invalidity or unenforceability of any other portion hereof, and all provisions of this Order are declared to be severable for that purpose.

Section 16. Appointment of Election Administrator. The Elections Administrator of Dallas County is hereby appointed Election Administrator for the District and agent for the custodian of voted ballots in the respective jurisdictions.

Section 17. Effective Date. This Order shall take effect immediately upon its approval.

UNA ORDEN DE LA JUNTA DE SÍNDICOS DEL DISTRITO ESCOLAR INDEPENDIENTE DE RICHARDSON QUE CONVOCA A UNA ELECCIÓN DE BONOS A CELEBRARSE DENTRO DEL DISTRITO; DISPONE LA CELEBRACIÓN Y LA ENTREGA DEL AVISO DE LA ELECCIÓN; E INCLUYE OTRAS DISPOSICIONES RELACIONADAS CON ESTO.

EN VISTA DE QUE la Junta de Síndicos (la "Junta") del Distrito Escolar Independiente de Richardson (el "Distrito") halla que se debería celebrar una elección para determinar si la Junta será autorizada o no a emitir bonos del Distrito por las cantidades y para los propósitos descritos más adelante en la presente; y

EN VISTA DE QUE la Junta halla y determina que todas las instalaciones a ser adquiridas, construidas, renovadas, mejoradas o equipadas en virtud de la Proposición A de este documento serán utilizadas predominantemente para la instrucción requerida en salón de clase y operaciones administrativas indispensables para plantel docente y personal; y

EN VISTA DE QUE la Junta halla y determina que la asamblea en la cual se considera esta Orden está abierta al público y que se dio aviso público de la hora, el lugar y el propósito de la asamblea de acuerdo con lo requerido por el Capítulo 551 del Código de Gobierno de Texas y sus enmiendas;

AHORA, POR LO TANTO, LA JUNTA DE SÍNDICOS DEL DISTRITO ESCOLAR INDEPENDIENTE DE RICHARDSON ORDENA:

Section 1. Hallazgos. Las declaraciones contenidas en el preámbulo de esta Orden son verdaderas y correctas y, por la presente, se adoptan como determinaciones de hechos y como parte de las disposiciones operativas de la presente.

Section 2. Elección ordenada; Fecha; Proposiciones. Se realizará una elección de bonos (la "Elección") en el Distrito el sábado 1 de mayo de 2021 ("Día de Elección"), una fecha de elección uniforme como se establece en la Sección 41.001(a) del Código Electoral de Texas y sus enmiendas (el "Código"). En la Elección se presentarán las siguientes proposiciones (individualmente la "Proposición" y en conjunto, las "Proposiciones") a los votantes habilitados del Distrito de acuerdo con la ley:

### RICHARDSON ISD – PROPOSICIÓN A

¿Se deberá autorizar a la Junta de Síndicos del Distrito Escolar Independiente de Richardson a emitir y vender bonos del Distrito en la cantidad de capital de \$694,000,000 para el propósito de adquirir, construir, renovar, mejorar y equipar edificios escolares del Distrito, para la compra de los predios necesarios para los edificios escolares, para la compra de nuevos autobuses escolares, para la actualización de autobuses escolares con equipamiento de emergencia, protección y seguridad y para la compra o actualización de vehículos a utilizarse para propósitos de emergencia, seguridad o protección; y se deberán imponer, tasar y recaudar impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito, suficientes, sin límite en cuanto a tasa o cantidad, para pagar el capital y el interés sobre dichos bonos conforme venzan y para pagar los costos de cualquier acuerdo de crédito firmado o autorizado en anticipo, relación o conexión con los bonos; dichos bonos a ser emitidos en una o más series o emisiones, con vencimiento en serie o de otra manera en no más de cuarenta (40) años desde su fecha y que devengarán interés a cierta tasa o tasas sin exceder el límite prescrito por ley en el momento de emisión, como determinará a su criterio la junta de síndicos?

¿Se deberá autorizar a la Junta de Síndicos del Distrito Escolar Independiente de Richardson a emitir y vender bonos del Distrito en la cantidad de capital de \$56,000,000 para el propósito de adquirir, mejorar y equipar tecnología e infraestructura tecnológica, incluidas computadoras y tabletas y otros dispositivos tecnológicos para el Distrito; y se deberán imponer, tasar y recaudar impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito, suficientes, sin límite en cuanto a tasa o cantidad, para pagar el capital y el interés sobre dichos bonos conforme venzan y para pagar los costos de cualquier acuerdo de crédito firmado o autorizado en anticipo, relación o conexión con los bonos; dichos bonos a ser emitidos en una o más series o emisiones, con vencimiento en serie o de otra manera en no más de cuarenta (40) años desde su fecha y que devengarán interés a cierta tasa o tasas sin exceder el límite prescrito por ley en el momento de emisión, como determinará a su criterio la junta de síndicos?

Section 4. Materiales bilingües de la Elección. Todos los avisos, instrucciones y boletas de votación relacionados con la Elección serán proporcionados a los votantes tanto en inglés como en español, y se pondrán a disposición personas capaces de desempeñarse como traductores en inglés y en español para asistir a los votantes de habla hispana a entender y participar en el proceso electoral.

Section 5. Personas habilitadas para votar. Todos los votantes habilitados residentes del Distrito serán elegibles para votar en la Elección.

Section 6. Precintos electorales, lugares de votación y horarios de votación del Día de Elección. Por la presente, Los lugares de votación para la Elección son designados como aquellos lugares identificados por el Administrador de Elecciones (como se define más adelante en este documento). Dichos lugares se indican en el Anexo A adjunto a la presente, que se incorpora por referencia a la presente para todo propósito; sin embargo, se dispone que dichos lugares pueden ser cambiados si así lo instruyera el Administrador de Elecciones sin una medida adicional del Distrito. Por la presente, se autoriza e instruye al Administrador de Elecciones del Condado de Dallas a que haga ciertos cambios de lugares de votación según sea necesario para la celebración adecuada de la Elección sin ninguna medida adicional del Distrito, y por la presente, se autoriza al Presidente de la Junta o su representante designado a actualizar el Anexo A para reflejar los sitios designados por el Condado de Dallas o el Administrador de Elecciones, lugares que, por la presente, se aprueban. El Día de Elección cada lugar de votación estará abierto de 7:00 a.m. a 7:00 p.m.

Section 7. Lugares, fechas y horarios de votación anticipada. (a) Se designa al Departamento de Elecciones del Condado de Dallas (el “Administrador de Elecciones”) como Oficial de votación anticipada para los propósitos de esta Elección (el “Oficial de votación anticipada”). Por la presente los lugares de votación anticipada y las direcciones para votar por anticipado por correo en la Elección son designados como se indican en el Anexo B; sin embargo, se dispone que dichos lugares pueden ser cambiados si así lo instruyera el Administrador de Elecciones sin medida adicional del Distrito. Por la presente se autoriza e instruye al Administrador de Elecciones a que haga ciertos cambios a lugares según sea necesario para la celebración adecuada de la Elección. Por la presente se autoriza al Presidente de la Junta o a su representante designado a actualizar el Anexo B para que refleje los lugares designados por el Administrador de Elecciones, y por la presente se aprueban dichos lugares. Por la presente se autoriza al Administrador de Elecciones y/o a la Oficial de votación anticipada a designar a los miembros del consejo de Boletas de Votación Anticipada y a los jueces presidentes y jueces alternos para cada lugar de votación de acuerdo con los requisitos del Código. Cada uno de los jueces presidentes estará autorizado para aprobar los funcionarios electorales necesarios para asistir en la celebración de las Elecciones.

(b) La votación anticipada en persona se llevará a cabo en los días y horarios indicados en el Anexo B, según puedan ser ajustados por el Administrador de Elecciones sin una medida adicional de la Junta.

(d) Los horarios de votación pueden ser cambiados si así lo instruyera el Administrador de Elecciones sin una medida adicional del Distrito. Por la presente se autoriza e instruye al Administrador de Elecciones a que haga ciertos cambios a horarios de votación según sea necesario para la celebración adecuada de la Elección.

Section 8. Designación de funcionarios electorales. La Elección será llevada a cabo bajo la jurisdicción del Departamento de Elecciones del Condado de Dallas (el “Administrador de Elecciones”) en virtud de un Contrato de Elecciones

Conjuntas (el “Contrato”), acordado entre el Distrito y otras entidades participantes, de haber alguna, descritas en el Contrato. El Contrato que dispone la elección conjunta y la celebración de la Elección por el Administrador de Elecciones se presentará ante la Junta para su consideración y aprobación. El Superintendente o el representante designado del Superintendente está autorizado a modificar o complementar el Contrato en la medida que sea requerido para que la Elección se lleve a cabo de manera eficiente y legal, según lo determine el Administrador de Elecciones.

Section 9. Aviso de Elección. Se dará aviso de dicha elección mediante (i) la publicación de una copia sustancial de esta Orden, en inglés y español una vez, no antes del trigésimo (30.mo) día antes ni más tarde del décimo (10.mo) día antes de la fecha programada de la Elección en un periódico publicado en el Distrito, (ii) la colocación de una copia de esta Orden, en inglés y español, en la cartelera de anuncios utilizada para colocar avisos de las asambleas de la Junta y en por lo menos otros tres (3) lugares públicos dentro de los límites del Distrito, no más tarde del vigésimo primer (21.er) día anterior a la fecha programada de la Elección, y (iii) la colocación de una copia de esta Orden, en inglés y español, en el sitio web del Distrito en un lugar destacado junto con el aviso de Elección y el contenido de la Proposición, no más tarde del vigésimo primer (21.er) día anterior a la fecha programada de la Elección y hasta el Día de Elección inclusive. Además, el Día de Elección y durante la votación anticipada en persona, esta Orden deberá estar colocada en un lugar destacado en cada lugar de votación. También se dará aviso de la Elección a los secretarios del condado y registradores de votantes del Condado de Lubbock y del Condado de Hockley no más tarde del 60.º día antes del Día de Elección. Por la presente se autoriza e instruye a cada Condado a colocar dicho aviso en su sitio web no después del vigésimo primer (21.er) día antes de la fecha programada para la Elección.

Section 10. Celebración de la Elección. La Elección se llevará a cabo en conformidad con el Código, salvo por las modificaciones del Código de Educación de Texas, el Código de Gobierno de Texas y la Ley Federal de Derechos de Votación de 1965 y sus enmiendas, incluido, sobre todo, el Capítulo 272 del Código respecto de los requisitos bilingües.

Section 11. Deuda pendiente del Distrito. A la fecha de entrada en vigencia de esta Orden, la cantidad total de capital de la deuda pendiente respaldada con impuestos del Distrito era de \$568,230,830 y la cantidad total de interés pendiente de dicha deuda respaldada con impuestos era de \$261,114,501. La tasa de impuestos ad valorem total del Distrito para el año fiscal actual era de \$1.4047, que está conformada por un componente de una tasa de impuesto de operaciones y mantenimiento de \$1.0547 por cada \$100 de tasación fiscal gravable y una tasa de impuestos para el servicio de la deuda de \$0.35 por cada \$100 de tasación fiscal. La tasación fiscal gravable del Distrito para el año calendario 2020, a la fecha en que se estableció la tasa de impuestos actual, era de \$26,603,714,558.

Section 12. Emisión de nueva deuda. El Distrito piensa emitir los bonos autorizados por las Proposiciones a lo largo de un período de años en una forma y de acuerdo con un cronograma que determinará la Junta basado en varios factores, incluidos, a título enunciativo pero no limitativo, las necesidades vigentes en ese momento del Distrito, los cambios demográficos, las condiciones prevalecientes del mercado, las tasaciones fiscales de propiedad en el Distrito y la administración de la exposición a las tasas de interés de corto y largo plazo del Distrito. Las condiciones del mercado, los índices demográficos y los valores de tasación de propiedades varían según varios factores que están fuera del control del Distrito; y por lo tanto, el Distrito no puede garantizar, y no lo hace, una determinada tasa de interés o tasa de impuesto asociada con los bonos autorizados por la Proposición. Por lo tanto, la información contenida en este párrafo se proporciona solamente con fines ilustrativos y no establece limitación ni restricción alguna ni crea un contrato con los votantes. El Distrito estima que, según la tasación fiscal gravable actual del Distrito, las condiciones actuales del mercado y el crecimiento futuro estimado en la tasación fiscal gravable del Distrito, si todos los bonos autorizados por la Proposición se emitieran de acuerdo con el plan de proyecto financiero actual del Distrito, la tasa de interés máxima de los bonos se prevé que no supere el 3.00%.

Section 13. Documento de información para los votantes. Por la presente, se autoriza e instruye al Presidente de la Junta, al Superintendente del Distrito o a su representante designado, actuando en nombre de la Junta y en consulta con el Abogado General y asesor de bonos del Distrito, a proveer un documento de información para los votantes en la forma prescrita por la Sección 1252.052(b) del Código de Gobierno de Texas (el “Documento de Información”).

Se autoriza e instruye además al Presidente de la Junta, al Superintendente del Distrito o su representante designado, actuando en nombre de la Junta, a colocar el Documento de Información de la misma manera dispuesta para el aviso de Elección en la Sección 9 de esta Orden y, adicionalmente, en el sitio web del Distrito de una manera que permita el fácil acceso a partir, a más tardar, del vigésimo primer (21.er) día antes de la fecha programada para la Elección y hasta el día después del Día de Elección.

Section 14. Medidas necesarias. Por la presente, se autoriza e instruye al Presidente de la Junta, al Superintendente del Distrito o a su representante designado, actuando en nombre de la Junta, en consulta con el Abogado General y asesor de bonos del Distrito, a tomar todas y cada una de las medidas necesarias para cumplir con las disposiciones del Código y de la Ley Federal de Derechos de Votación para realizar y celebrar la Elección, sean expresamente autorizadas en la presente o no, incluso a hacer cambios o adiciones de lugares de votación o procedimientos electorales en la medida que sean requeridos o deseables o como puedan volverse necesarios debido a circunstancias que surjan con posterioridad a la fecha de esta Orden.

Section 15. Divisibilidad. Si cualquier disposición, sección, subsección, oración, cláusula o frase de esta Orden o la aplicación de ella a cualquier persona o conjunto de circunstancias es por alguna razón hallada inconstitucional, nula, no válida o imposible de hacer cumplir, ni las partes restantes de esta Orden ni su aplicación a otras personas o conjunto de circunstancias será afectada por esto, en tanto la intención de la Junta al adoptar esta Orden es que ninguna parte de ella o disposición o norma contenida

en la presente llegue a ser inoperativa o falle debido a la inconstitucionalidad, nulidad, no validez o imposibilidad de cumplimiento de cualquier otra parte de ella, y todas las disposiciones de esta Orden se declaran divisibles a tales efectos.

Section 16. Designación de Administrador de Elecciones. Por la presente se designa al Administrador de Elecciones del Condado de Dallas como Administrador de Elecciones para el Distrito y agente para la custodia de los votos emitidos en las jurisdicciones respectivas.

Section 17. Fecha de entrada en vigencia. Esta Orden entrará en vigencia inmediatamente después de su aprobación.
